MEETINGS OF THE BOARD OF TRUSTEES

23. The Board of Trustees may meet for the dispatch of business, adjourn or otherwise regulate its meetings as it thinks fit. Meetings of the Board of Trustees shall be convened by the chairperson (either on his/her own accord or at the request of nine or more trustees) giving at least one week's written notice to the Trustees. The Board shall meet at least once in three months.
24. The quorum of the meetings of the Board of Trustees shall be seven Trustees out of whom at least five shall be Life Trustees.
25. The chairperson shall keep or cause to be kept minutes of all proceedings at every meeting of the Board of Trustees. Such minutes shall contain a fair and correct summary of the proceedings thereat. The draft minutes shall be circulated amongst the Trustees and confirmed (with or without alterations) at the succeeding meeting. The confirmed minutes shall be conclusive evidence of the proceedings reported therein.
26. All questions arising at any meeting of the Board of Trustees shall be decided by a majority of votes. In case of equality of votes, the chairperson of the Board shall have a second or casting vote.
27. A resolution in writing signed by all the Trustees for the time being shall be as valid and effectual as if it had been passed at a meeting of the Board of Trustees duly convened and held.
28. The Board of Trustees may delegate any of its powers and functions to one or more Trustees as it thinks fit. Such Trustees shall conform to any regulations imposed by the Board of Trustees. Such Trustee/s may be designated Secretary, Treasurer, Managing Trustee, etc., as would be appropriate to the functions performed by him/her.

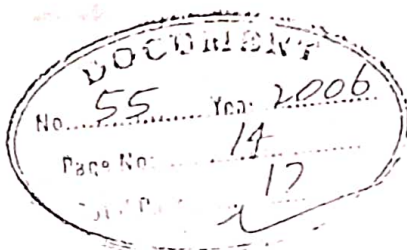

ADMINISTRATION OF TRUST

29. The Board of Trustees shall have full powers to do all such acts as they may deem necessary and conducive or incidental to the attainment and promotion of the objects of the Trust and shall have full control of all the activities, functions, properties and staff of the Trust. Without prejudice to the generality of the foregoing, the Board of Trustees is empowered to do any or all of the following:

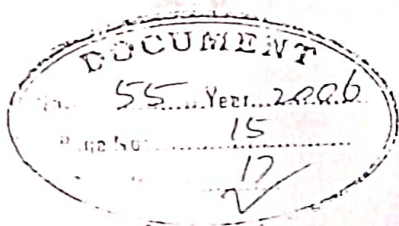
- a. To adopt, make, vary, and repeal rules for the regulating and administration of the Trust or any unit of section thereof.
- b. To determine the manner in which bill, notes, receipts, acceptances, endorsements, cheques, releases, contracts and documents shall be signed and executed on behalf of the Trust.
- c. To enter into all negotiations and contracts and to rescind and vary all such contracts and to undertake the performance of all covenants, conditions and agreements contained or reserved by such contracts.
- d. To raise, collect and receive monies required for all or any of the objects of the Trust, by way of subscriptions, gifts, sponsorships, donations in cash or kind and to organize such fund raising programmes as may be thought fit.
- e. To acquire (by purchase, grant, gift, lease or otherwise) properties movable or immovable and to sell, transfer, lease or otherwise deal with the properties and the rents and profits arising therefrom.
- f. To employ agents, consultants, lawyers, accountants and others on such terms and remuneration as may be thought fit.

- g. To appoint, suspend and remove such managers, secretaries, officers, assistants and other employees for permanent, temporary or special services as deemed necessary from time to time and to determine their powers and duties and to fix their salaries, perquisites and other conditions of service.
- h. To donate, help and assist financially or otherwise any other charitable association, trusts, institutions etc.
- i. To delegate any of the powers of the Board of Trustees to one or more among themselves.
- j. To take on and let out on lease any immovable property on such rent and such terms as may be thought fit.
- k. To borrow money with or without security and pledge, mortgage or otherwise charge any of the properties belonging to the Trust.
- l. To open, close and operate Bank Accounts.
- m. To invest the funds of the Trust and to vary such investments from time to time as they think fit in government securities, fixed deposits with banks or companies, debentures, bonds, units of the Unit Trust of India or other mutual funds, immovable properties or in any other manner thought fit and to vary all such investments provided such investments shall always be in conformity with section 11 to 13 of the Income-tax Act, 1961.
- n. To institute, conduct, or defend, compound or abandon any legal proceedings by or against the Trust or otherwise concerning the affairs of the Trust and to refer any dispute to Arbitration.
- o. To undertake or do all other acts, deeds and things as are necessary, conducive, suitable or ancillary and incidental to any of the objects of the Trust.

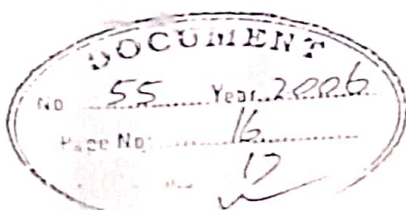
26. The Board of Trustees may from time to time appoint committees for any special purposes, including for assisting the Board (i) in the formulation of policies and programmes, (ii) in the execution and follow-up of its decisions relating to the promotion of the objects and (iii) in administering any institution set up by the Trust. The Board of Trustees may delegate to any such committee any of its functions and powers, subject to any conditions or restrictions as it thinks proper. The Board of Trustees may make, vary and repeal byelaws and rules for the regulation of the committees constituted by it. The Board of Trustees may abandon any such committee at its absolute discretion.

The Trustees shall be indemnified in respect of any act done by them in good faith and in defending any proceedings, whether civil or criminal, in relation to the affairs of the Trust.

27. A Trustee shall not be disqualified from contracting with the Trust either as a vendor, purchaser or for rendering professional services to the Trust or otherwise nor shall any Trustee on contracting or being interested in any manner be liable to account to the Trust for any profit realized by any such contract. However every Trustee who in any way, whether directly or indirectly, is concerned or interested in any contract or arrangement shall disclose the nature of his/her concern or interest at a meeting of the Board of Trustees.

ACCOUNTS AND AUDIT

28. The Trustees shall maintain or cause to be maintained accounts of all receipts, payments, income, expenditure, assets and liabilities of the Trust. The accounts shall be closed on the 31st day of March every year and an Income and Expenditure Account and Balance Sheet prepared.
